AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE USE DISTRICT MAP OF THE CITY OF LONG BEACH AS SAID MAP HAS BEEN ESTABLISHED AND AMENDED BY AMENDING PORTIONS OF PART 19 OF SAID MAP FROM RANCHO ESTATES PLANNED DEVELOPMENT DISTRICT (PD-11) TO SINGLE FAMILY RESIDENTIAL (R-1-N)

ORDINANCE NO. ORD-09-0019

The City Council of the City of Long Beach ordains as follows:

13 Section 1. Environmental documentation having been prepared, certified, 14 received and considered as required by law, and the City Council hereby finding that the 15 proposed change will not adversely affect the character, livability or appropriate 16 development of the surrounding area and that the proposed change is consistent with the 17 goals, objectives and provisions of the General Plan, the official Use District Map of the 18 City of Long Beach, as established and amended, is further amended by amending 19 portions of Part 19 of said Map to rezone the subject property from Rancho Estates 20 Planned Development District (PD-11) to (Single Family Residential) R-1-N. Those 21 portions of Part 19 of said map that are amended by this ordinance are depicted on 22 Exhibit "A" which is attached hereto and by this reference made a part of this ordinance 23 and the official Use District Map.

Section 2. All ordinances and parts of ordinances in conflict herewith arehereby repealed.

26 Section 3. The City Clerk shall certify to the passage of this ordinance by 27 the City Council and cause it to be posted in three conspicuous places in the City of Long 28 Beach, and it shall take effect on the thirty-first day after it is approved by the Mayor.


