A RESOLUTION TO TEMPORARILY CLOSE AND REMOVE FROM PUBLIC USE CERTAIN STREETS AND ALLEYS IN THE CITY OF LONG BEACH IN CONNECTION WITH THE CONDUCT OF THE 2005 TOYOTA GRAND PRIX OF LONG BEACH

The City Council of the City of Long Beach resolves as follows:

Section 1. The City Council of the City of Long Beach finds and determines that the conduct of the 2005 Toyota Grand Prix of Long Beach on the streets of the City of Long Beach and the coverage thereof by the media provides a unique opportunity for the City of Long Beach to publicize and call attention to the City, its natural advantage, resources, enterprises, attractions, climate and facilities.

Sec. 2. For the conduct of the 2005 Toyota Grand Prix of Long Beach, the following streets will hereby have temporary lane reductions for the periods stated:

a. From February 7, 2005 at 9:00 a.m. to May 14, 2005, at 11:59 p.m., Shoreline Drive westbound from Ocean Boulevard to Long Beach Arena service road (reduce existing three lanes of two lanes).

b. From February 7, 2005, at 7:00 a.m. to May 14, 2005, at 11:59 p.m., Shoreline Drive eastbound from Linden to Ocean Boulevard (reduce existing three lanes to two lanes).

c. From February 18, 2005 at 7:00 a.m. to May 3, 2005 at 11:59 p.m., Seaside Way, westbound from Pine Avenue to Linden Avenue (reduce existing two lanes to one lane in each direction).

d. From February 24, 2005 at 7:00 a.m. to April 26, 2005 at 11:59 p.m., Pine Avenue from Ocean Boulevard southbound to Shoreline Drive

2 Sec. 3. For the conduct of the 2005 Toyota Grand Prix of Long Beach, the  
3 following streets, alleys, promenade and bike path are hereby temporarily closed for the  
4 periods stated:

5 a. On March 29, 2005, from 8:15 a.m. to 3:15 p.m., Shoreline Drive  
6 eastbound from Broadway off-ramp to Ocean Boulevard, Golden Shore on-  
7 ramp to Shoreline Drive eastbound, Shoreline Village Drive to Shoreline Drive  
8 eastbound and westbound, Shoreline Drive westbound from Ocean Boulevard  
9 to Chestnut Place northbound, Chestnut Place southbound and northbound  
10 from Seaside Way to Queensway Bridge, Seaside Way from Shoreline Drive  
11 to Linden Avenue and Aquarium Way from Shoreline Drive to Chestnut Place.

12 b. On March 29, 2005, from 9:45 a.m. to 10:15 a.m., 10:45 a.m.  
13 to 11:15 a.m., 1:15 p.m. to 1:45 p.m., and 2:15 p.m. to 2:45 p.m., Pine  
14 Avenue from Ocean Boulevard to Shoreline Drive, Linden Avenue from  
15 Ocean Boulevard to Shoreline Drive. Seaside Way from Linden Avenue to  
16 Marina Way (eastern end).

17 c. From April 6, 2005, at 7:00 a.m. to April 11, 2005 at 5:00 p.m.,  
18 Seaside Way from Pine Avenue to eastern end, Linden Avenue from Ocean  
19 Boulevard to Seaside Way, Marine Way from Locust Avenue to Collins Way,  
20 Atlantic Way from Ocean Boulevard to Seaside Way, Marine Way from Hart  
21 Place to eastern end, Linden Avenue, northbound and southbound from  
22 Shoreline Drive to Marina Parking lot.

23 d. From April 6, 2005, at 9:00 a.m. to April 11, 2005, at 5:00 p.m.,  
24 Shoreline Drive westbound from Ocean Boulevard and Alamitos to Ocean  
25 Boulevard exit ramp northbound, Chestnut Place southbound and northbound  
26 from Seaside Way to Queensway Bridge.

27 e. From April 6, 2005, at 6:00 p.m. to April 11, 2005, at 5:00 p.m.,  
28 Shoreline Drive eastbound from Broadway off-ramp to Ocean Boulevard,

1 Golden Shore on-ramp to Shoreline Drive eastbound, Shoreline Village Road  
2 to Marina Parking lot to Shoreline Drive, Aquarium Way from Shoreline Drive  
3 to Chestnut Place, and Cedar Avenue at Shoreline Drive

4 f. On April 8, 9, and 10, 2005, from 6:00 a.m. to 7:00 p.m., Pine  
5 Avenue from Ocean Boulevard to Pine Circle.

6 g. On April 8, 9, and 10, 2005, from 6:00 a.m. to 7:00 p.m.,  
7 Promenade South from Seaside Way to Shoreline Drive Terminus.

8 h. On April 6, 2005, at 7:00 a.m. to April 11, 2005, at 11:59 p.m.,  
9 the Bike Path beginning at Seaside Way and Chestnut Place East to a point  
10 approximately four hundred feet (400') east of the permanent concession  
11 stand behind the Villa Riviera.

12 Sec. 4. The temporary closing of the above streets, alleys, Promenade and  
13 Bike Path for the times herein provided is necessary for the safety and protection of the  
14 participants and spectators in the 2005 Toyota Grand Prix of Long Beach and qualifying  
15 events to be held from April 8, 2005 through April 10, 2005, utilizing the streets described  
16 herein.

17 Sec. 5. For the period of 9:00 a.m. to 3:00 p.m. on March 29, 2005, the  
18 streets and alleys described in Sections 3.c. and 3.d. above are hereby withdrawn and  
19 removed from public use.

20 Sec. 6. For the period April 8, 2005, at 6:00 a.m. to April 10, 2005, at 11:59  
21 p.m., Shoreline Drive from Ocean Boulevard to Chestnut Place, Chestnut Place from  
22 Shoreline Drive to Seaside Way, Pine Avenue from Ocean Boulevard to Shoreline Drive  
23 and Seaside Way from Pine Avenue to eastern end are hereby withdrawn and removed  
24 from public use.

25 Sec. 7. For the period of April 8, 2005 at 6:00 a.m. to April 10, 2005 at 6:00  
26 p.m., Seaside Way from Chestnut Place to the eastern limit (dead end beyond Linden), Bay  
27 Street from Pine Avenue to the Pike Garage Structure, Aquarium Way from Seaside Way  
28 to Shoreline Drive, Cedar Avenue from Shoreline Drive to Seaside Way, Paseo from Pine

2           Sec. 8. For the period of April 6, 2005 at 6:00 a.m. to April 11, 2005 at 5:00  
3 p.m., Seaside Way from Bay Street to Pine Avenue.

4           Sec. 9. The City Manager is authorized and directed to post notices of the  
5 intent to temporarily reduce lanes, close the streets, alleys and portions of the Promenade  
6 described in Sections 2, 3, 5, 6, 7 and 8 above at least twenty-four (24) hours prior to the  
7 closure thereof.

8           Sec. 10. This resolution shall take effect immediately upon its adoption by the  
9 City Council, and the City Clerk shall certify the vote adopting this resolution.
