

SECOND AMENDMENT TO AGREEMENT NO. 31944

THIS SECOND AMENDMENT TO AGREEMENT NO. 31944 is made and entered, in duplicate, as of September 4, 2012, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 9, 2010, by and between MICHAEL J. ARNOLD AND ASSOCIATES, INC., a California corporation ("Consultant"), with a place of business at 1127 11<sup>th</sup> Street, Suite 820, Sacramento, California 95814, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, there is a need to hire a legislative advocate to assist City in keeping informed about activities in the State Capitol that may affect the citizens of City and their municipal government; and

WHEREAS, there is a need to retain expert assistance to help City formulate and communicate in the most effective ways City's policies and positions to the California Legislature and State agencies, including the members of the Long Beach Legislative Delegation; and

WHEREAS, the parties entered Agreement No. 31944 whereby Consultant agreed to provide such services; and

WHEREAS, the parties desire to extend the term of the Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in Agreement No. 31944 and herein, the parties agree as follows:

1. Section 5 of Agreement No. 31944 is hereby amended in its entirety to read as follows:

“5. TERM OF AGREEMENT. The term of this Agreement shall begin at midnight on October 1, 2010 and shall terminate at 11:59 p.m. on September 30, 2013, unless sooner terminate as provided in this Agreement.”


2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 31944 are ratified and confirmed and shall remain in full

1 force and effect.


