

1 SIXTH AMENDMENT TO AGREEMENT NO. 33392

3 THIS SIXTH AMENDMENT TO AGREEMENT NO. 33392 is made and
4 entered, in duplicate, as of December 7, 2016, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 November 3, 2015, by and between THE RYTE PROFESSIONALS, a corporation, located
7 at 4141 Ball Road, #517, Cypress, California 90630 ("Consultant"), and the CITY OF LONG
8 BEACH, a municipal corporation ("City").

9 WHEREAS, the City requires specialized services requiring unique skills to
10 be performed on an as-needed basis in connection with professional and technical services
11 for information technology projects and systems; and

12 WHEREAS, City and Consultant entered into Agreement No. 33392 (the
13 "Agreement") whereby Consultant agreed to provide these services; and

14 WHEREAS, City and Consultant entered into the First Amendment to the
15 Agreement to increase the not to exceed amount to \$100,000; and

16 WHEREAS, City and Consultant entered into the Second Amendment to the
17 Agreement to increase the not to exceed amount to \$200,000; and

18 WHEREAS, City and Consultant entered into the Third Amendment to the
19 Agreement to increase the not to exceed amount to \$400,000 and extend the term to
20 January 22, 2017; and

21 WHEREAS, City and Consultant entered into the Fourth Amendment to the
22 Agreement to increase the not to exceed amount to \$600,000; and

23 WHEREAS, City and Consultant entered into the Fifth Amendment to the
24 Agreement to increase the not to exceed amount to \$900,000; and

25 WHEREAS, City and Consultant again desire to increase the total not to
26 exceed amount and extend the term;

27 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
28 conditions herein contained, the parties agree as follows:
