3 THIS SECOND AMENDMENT TO CONTRACT NO. 35109 is made and  
4 entered, in duplicate, as of September 14, 2021 for reference purposes only, pursuant to  
5 Resolution No. RES-18-0122, adopted by the City Council of the City of Long Beach at its  
6 meeting on August 14, 2018, by and between TROY SHEET METAL WORKS, INC., a  
7 California corporation ("Contractor"), with a place of business at 1024 S. Vail Avenue,  
8 Montebello, CA 90640, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City desired to purchase command equipment boxes for  
10 police vehicles ("Command Equipment Boxes"); and

11 WHEREAS, City and Contractor (the "Parties") entered into Contract No.  
12 35109 (the "Contract") whereby Contractor agreed to furnish the Command Equipment  
13 Boxes; and

14 WHEREAS, the Parties entered a First Amendment to extend the term of the  
15 Contract;

16 WHEREAS, the Parties desire to amend the contract to extend the term for  
17 an additional one-year period and increase the contract amount by One Hundred Sixty-five  
18 Thousand Dollars (\$165,000);

19 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
20 conditions herein contained, the Parties agree as follows:

21 1. Section 2. of the Contract is hereby amended to read as follows:

22 "2. City shall pay Contractor in due course of payments, following  
23 receipt of an invoice from Contractor and upon acceptance from City, for command  
24 equipment boxes for police vehicles, the prices shown in Exhibit "A", a sum not to exceed  
25 One Hundred Sixty-Five Thousand Dollars (\$165,000).

26 2. Section 3 of the Contract is hereby amended to read as follows:

27 "3. The term of this Contract shall commence on August 15, 2018, and  
28 shall terminate at midnight on August 14, 2022, with the option to renew for one (1)

1 additional one-year term, unless sooner terminated as provided herein. The City may  
2 terminate this Contract by giving thirty (30) days prior notice of termination to Contractor."

3 3. Except as expressly modified herein, all of the terms and conditions  
4 contained in Contract No. 35109 are ratified and confirmed and shall remain in full force  
5 and effect.
