SECOND AMENDMENT TO AGREEMENT NO. 34940

THIS SECOND AMENDMENT TO AGREEMENT NO. 34940 is made and entered, in duplicate, as of May 13, 2022, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 17, 2018, by and ELITE LINE SERVICES, INC., a Florida corporation ("Contractor"), with a place of business at 1505 Luna Road, Suite 100, Carrollton, Texas 75006, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 34940 (the "Agreement") whereby Contractor agreed to provide baggage handling system maintenance at the Long Beach Airport; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to May 31, 2022 and add \$1,039,638 to the extension; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period and add \$1,048,263 to the extension;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

Contractor shall furnish specialized services more particularly described in Request for Proposals (RFP) AP18-035, attached to the Agreement as Exhibit "A" and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, Three Million Eighteen Thousand Two Hundred Ninety-Three Dollars (\$3,018,293) for the term June 1, 2018 through May 31, 2021, One Million Thirty-Nine Thousand Six Hundred Thirty-Eight Dollars (\$1,039,638) for the term June 1, 2021 through May 31, 2022, and One Million Forty-Eight Thousand Two Hundred Sixty-Three Dollars (\$1,048,263) for the term June 1, 2022 through May 31, 2023, at the rates or charges shown in Exhibit "B"."
