SECOND AMENDMENT TO AGREEMENT NO. 35671

35671

THIS SECOND AMENDMENT TO AGREEMENT NO. 35671 is made and entered, in duplicate, as of October 14, 2022 for reference purposes only, pursuant to Resolution No. RES-20-0097 adopted by the City Council of the City of Long Beach at its meetings on August 11, 2020 and May 24, 2022, by and between W.W. GRAINGER, INC., an Illinois corporation ("Contractor"), whose address is 100 Grainger Parkway, Lake Forest, IL 60045, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35671 (the "Agreement") to purchase maintenance, repair, and operations supplies and related materials for a wide range of fieldwork needs; and

WHEREAS, the Parties entered into a First Amendment to increase the annual amount by \$300,000 with a twenty percent contingency in the amount of \$60,000, for a revised total agreement amount not to exceed \$1,560,000; and

WHEREAS, the Parties currently desire to enter into a Second Amendment to extend the term of the contract for an additional one-year period;

NOW, THEREFORE, in consideration of the terms and conditions herein contained, the Parties agree as follows:

1. Section 1.D. of the Agreement is hereby amended to read as follows:

"D. The term of this Agreement shall commence at midnight on August 12, 2020, and shall terminate at 11:59 p.m. on December 31, 2023, with the option to renew for as long as the Omnia Partners contract is in effect, at the discretion of the City Manager."

2. Except as expressly amended herein, all terms and conditions in Agreement No. 35671 are ratified and confirmed and shall remain in full force and effect.


