**WHEREAS**, reference is made to that certain document entitled "Intermediary Contract Youth Employment Program (YEP) Contract Period July 2011 – June 2012 Contract Number IA1101," dated July 1, 2011, and any amendments thereto (all hereafter referred to as "Contract"); and

**WHEREAS**, the parties hereto have previously entered into intermediary agreements with Workforce Investment Boards (WIBs) for the purpose of procuring qualified non-profit community-based organizations and governmental agencies (subcontractors) to provide paid work experience for low income, foster, probation, General Relief and CaWORKs youth between the ages of 16 and 21, residing in Los Angeles County; and

**WHEREAS**, it is the intent of the parties hereto to amend Contract to provide a time-only extension, for an additional nine (9) months, effective **October 31, 2011 through June 30, 2012**, with no additional funds, in order to provide YEP services to participants; and

**WHEREAS**, Contract provides that further changes to its terms may be made in the form of a written Amendment which is formally approved and executed by the parties.

**NOW THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:**

- I. This Amendment shall commence upon execution by all parties.
