# INTERMEDIARY CONTRACT FOR YOUTH EMPLOYMENT PROGRAM (YEP) CONTRACT PERIOD JULY 2011 - JUNE 2012

#### AMENDMENT NUMBER ONE

This Amendment is made and entered into by and between

COUNTY OF LOS ANGELES THROUGH ITS DEPARTMENT OF COMMUNITY AND SENIOR SERVICES ("CSS") (hereafter "COUNTY")

And

CITY OF LONG BEACH
ADMINISTERING ENTITY FOR
PACIFIC GATEWAY WORKFORCE INVESTMENT NETWORK
(hereafter "CONTRACTOR")

WHEREAS, reference is made to that certain document entitled "Intermediary Contract Youth Employment Program (YEP) Contract Period July 2011 – June 2012 Contract Number IA1101," dated July 1, 2011, and any amendments thereto (all hereafter referred to as "Contract"); and

WHEREAS, the parties hereto have previously entered into intermediary agreements with Workforce Investment Boards (WIBs) for the purpose of procuring qualified non-profit community-based organizations and governmental agencies (subcontractors) to provide paid work experience for low income, foster, probation, General Relief and CalWORKs youth between the ages of 16 and 21, residing in Los Angeles County; and

WHEREAS, it is the intent of the parties hereto to amend Contract to provide a time-only extension, for an additional nine (9) months, effective October 31, 2011 through June 30, 2012, with no additional funds, in order to provide YEP services to participants; and

WHEREAS, Contract provides that further changes to its terms may be made in the form of a written Amendment which is formally approved and executed by the parties.

### **NOW THEREFORE**, THE PARTIES HERETO AGREE AS FOLLOWS:

I. This Amendment shall commence upon execution by all parties.

- II. Contract, Part I: Unique Terms and Conditions, Section 4.0, Term and Termination, Subsection 4.2, is deleted in its entirety and replaced as follows:
  - 4.2 The County shall have the sole option to extend the Contract term for up to an additional one (1) year for a maximum contract term of fifteen (15) months. Such option and extension shall be in compliance with federal and State procurement laws, and shall be exercised at the sole discretion of the Director, provided that approval of COUNTY'S Chief Executive Office (CEO) is obtained prior to any such extension.
    - 4.2.1 The COUNTY desires to exercise its option to extend the term of this Contract for an additional nine (9) months, effective October 31, 2011 through June 30, 2012.

All other terms and conditions of the Contract shall remain in full force and effect.
