WHEREAS, City and Grantee entered into Cares Act Grant Agreement No. 35711 whereby City agreed to provide funding to the Grantee to administer digital inclusion resources and services; and

WHEREAS, City and Grantee desire to extend the program and add additional funds;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, City and Grantee agree as follows:

- 1. The Performance Period for the Project shall be extended to February 26, 2021, unless sooner terminated as provided in this Agreement, or unless the services to be performed or the Project is completed sooner.
- 2. An additional Two Hundred Four Thousand Dollars (\$204,000) in grant funds is hereby added to the Agreement for a total not to exceed amount of Seven Hundred Ninety-Four Thousand Dollars (\$794,000).
- 3. Except as expressly amended herein, all terms and conditions in Cares Act Agreement No. 35711 are ratified and confirmed and shall remain in full force and effect.
