1 SIXTH AMENDMENT TO AGREEMENT NO. 34376

3 THIS SIXTH AMENDMENT TO AGREEMENT NO. 34376 is made and  
4 entered, in duplicate, as of August 4, 2021, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on August  
6 3, 2021, by and between ANDERSONPENNA PARTNERS, INC., a California corporation  
7 (“Consultant”), with a place of business at 3737 Birch Street, Newport Beach, California  
8 92660, and the CITY OF LONG BEACH, a municipal corporation (“City”).

9 WHEREAS, City and Consultant (the “Parties”) entered into Agreement No.  
10 34376 (the “Agreement”) whereby Consultant agreed to provide as-needed public works  
11 construction management and inspection services; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to  
13 add \$1,000,000 for a total not to exceed amount of \$2,000,000; and

14 WHEREAS, the Parties entered into a Second Amendment to the Agreement  
15 to add \$1,000,000 for a total not to exceed amount of \$3,000,000; and

16 WHEREAS, the Parties entered into a Third Amendment to the Agreement  
17 to increase the rates to align with prevailing wages; and

18 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement  
19 to add \$500,000 for a total not to exceed amount of \$3,500,000 and extend the term to  
20 August 31, 2020; and

21 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to  
22 add \$500,00 for a total not to exceed amount of \$4,000,000 and extend the term to August  
23 31, 2021; and

24 WHEREAS, the Parties desire to add \$300,000 to the Agreement for a total  
25 not to exceed amount of \$4,300,000 and extend the term one (1) additional one-year  
26 period;

27 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
28 conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows:

A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Four Million Three Hundred Thousand Dollars (\$4,300,000), at the rates or charges shown in Exhibit "B".

2. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on August 31, 2016, and shall terminate at 11:59 p.m. on August 31, 2022, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

3. Except as expressly amended herein, all terms and conditions in Agreement No. 34376 are ratified and confirmed and shall remain in full force and effect.






