

1 THIRD AMENDMENT TO AGREEMENT NO. 31923

3 THIS THIRD AMENDMENT TO AGREEMENT NO. 31923 is made and
4 entered, in duplicate, as of December 3, 2013 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on April
6 23, 2013, by and between HDR ENGINEERING, INC., a Nebraska corporation, with a
7 place of business at 3230 El Camino Real, Suite 200, Irvine, California 92602-1377
8 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City requires specialized services requiring unique skills to
10 be performed in connection with As-Needed Engineering Consulting Services; and

11 WHEREAS, the parties entered Agreement No. 31923 whereby Consultant
12 agreed to provide As-Needed Engineering Consulting Services; and

13 WHEREAS, the parties desire to increase the Agreement amount by
14 \$200,000;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the parties agree as follows:

17 1. Section 1.A. of Agreement No. 31923 is hereby amended to read as
18 follows:

19 "1. SCOPE OF WORK OR SERVICES.

20 A. Consultant shall furnish specialized services more particularly
21 described in Exhibit "A", attached to this Agreement and incorporated by this
22 reference, in accordance with the standards of the profession, and City shall pay
23 for these services in the manner described below, not to exceed Nine Hundred
24 Seventy-Five Thousand Dollars (\$975,000), at the rates or charges shown in
25 Exhibit "B".

26 2. Except as expressly modified herein, all of the terms and conditions
27 contained in Agreement No. 31923 are ratified and confirmed and shall remain in full
28 force and effect.
