

RESOLUTION NO. RES-07-0065

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH DECLARING THE RESULTS OF THE SPECIAL MUNICIPAL ELECTION HELD IN THE CITY OF LONG BEACH, CALIFORNIA, ON TUESDAY, MAY 1, 2007, FOR THE PURPOSE OF ELECTING A CANDIDATE FOR THE OFFICE OF MEMBER OF THE CITY COUNCIL FROM THE SIXTH COUNCILMANIC DISTRICT; AND DIRECTING THE CITY CLERK TO ISSUE A CERTIFICATE OF ELECTION TO THE CANDIDATE DECLARED TO HAVE BEEN ELECTED AT THE SPECIAL ELECTION

WHEREAS, the City Council of the City of Long Beach did, by Resolution No. RES-07-0002, declare a vacancy in the Office of Member of the City Council for the Sixth Councilmanic District, and did duly call and provide for the holding of a Special Municipal Election on Tuesday, May 1, 2007, for the purpose of electing a candidate for the Office of Member of the City Council for the Sixth Councilmanic District; and

WHEREAS, the election was held in the City of Long Beach in the Sixth Councilmanic District on that day; and

WHEREAS, the City Clerk, pursuant to Long Beach Municipal Code Section 1.21.010, duly canvassed the returns of the election; and

WHEREAS, the absentee ballots issued in connection with the election which were returned as required by law have been included;

NOW, THEREFORE, the City Council of the City of Long Beach does resolve, determine, order and declare as follows:

Section 1. That the Special Municipal Election for the purpose of electing a candidate as required by law for the Office of Member of the City Council, Sixth

1 Councilmanic District, was duly held on Tuesday, May 1, 2007, and the votes cast,  
2 including the absent voter ballots issued in connection with the election which were  
3 returned at the time and in the form and manner required by law, were all duly and  
4 regularly canvassed. That the City Clerk has duly canvassed the returns of the election  
5 for a Member of the City Council and filed his Certificate of Canvass with the City Council  
6 and from that certification and return the City Council finds that the total number of votes  
7 cast in the district, the total number of votes cast in each of the respective election  
8 precincts established for the election, the number of votes cast for each candidate in  
9 each precinct and the total number of votes for each candidate are as provided in Exhibit  
10 "A" attached to and made a part of this resolution.

11 Section 2. That the candidates were nominated as required by law for  
12 the Office of Member of the City Council from the Sixth District, and the names of the  
13 persons voted for at the election, were:

21 Section 3. That Dee Andrews received a plurality of the votes cast for all  
22 candidates for the Office of Member of the City Council from the Sixth District and in  
23 accordance with the provision of law governing the election of candidates for this office,  
24 Dee Andrews is declared elected to the Office of Member of the City Council from the  
25 Sixth District for a partial term commencing May 22, 2007. The City Clerk is directed to  
26 issue to Dee Andrews a Certificate of Election certifying to the election to this office for  
27 such term.

28 Section 4. This resolution shall take effect immediately upon its adoption  
by the City Council, and the City Clerk shall certify the vote adopting this resolution.


