3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO PURCHASE CELLULAR TELEPHONE
6 SERVICE THROUGH THE CONTRACT BETWEEN NEXTEL
7 OF CALIFORNIA, INC., DOING BUSINESS AS NEXTEL
8 COMMUNICATIONS AND THE STATE OF CALIFORNIA

10 WHEREAS, the Charter of the City of Long Beach, Section 1802, permits
11 the City to purchase services, supplies, materials, equipment, and labor with other
12 government agencies by purchasing under their contracts on a voluntary and selective
13 basis when authorized by resolution; and

14 WHEREAS, the City of Long Beach desires to purchase cellular
15 telephone service from Nextel Communications; and

16 WHEREAS, the State of California ("State") has a contract for the
17 purchase of Nextel cellular telephone service known as Price Agreement No. 1S-05-58-
18 01 ("Price Contract"); and

19 WHEREAS, City's participation in the Price Contract will facilitate
20 acquisition of the cellular telephone service as well as provide considerable cost
21 benefits to the City; and

22 WHEREAS, if the City had to go to formal bid rather than participate in the
23 Price Contract considerably more funds would be required;

24 NOW, THEREFORE, the City of Long Beach resolves as follows:

25 Section 1. The above recitals are true and correct and are incorporated
26 herein by this reference.

27 Sec. 2. The City Manager of the City of Long Beach is hereby authorized
28 to enter an agreement with Nextel Communications for the purchase of cellular

1 telephone service as ordered by the City of Long Beach, pursuant to the Price Contract.
2 The purchase by the City of Long Beach shall be on the same terms and conditions
3 afforded to the State, in an amount not to exceed \$504,000.00 annually.

4 Sec. 3. This resolution shall take effect immediately on its adoption by the
5 City Council, and the City Clerk shall certify the vote adopting this resolution.
