3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH GRANTING PERMISSION TO  
5 MEMBERS OF THE PUBLIC TO PARK IN THE CIVIC  
6 CENTER BROADWAY PARKING GARAGE AND THE  
7 CEDAR AVENUE PARKING LOT ADJACENT TO CITY  
8 HALL AND GRANTING PERMISSION TO PARK IN THE  
9 LINCOLN PARK GARAGE DURING SPECIFIED SPECIAL  
10 EVENTS, ESTABLISHING FEES RELATED THERETO  
11 AND AMENDING AND RESTATING THE CONDITIONS  
12 AND REGULATIONS WITH RESPECT TO SAID PARKING

14 WHEREAS, the conditions and regulations pertaining to public parking in  
15 the Civic Center Broadway parking garage has been established by the City Council; and

16 WHEREAS, the City Council desires to grant permission to members of the  
17 public to park in the Lincoln Park parking garage, the parking lot at the corner of Cedar  
18 and Third Street, known as the Cedar Avenue parking lot, and during special events, in  
19 the Lincoln Park garage under certain conditions;

20 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
21 follows:

22 Section 1. Any person may park a vehicle in the Civic Center Broadway  
23 parking garage adjoining the City Hall on the north, the Cedar Avenue parking lot and the  
24 Lincoln Park garage subject to the schedule attached as Exhibit "A".

25 Section. 2. Prior to the adoption of this resolution, public notice and  
26 hearing have been given in compliance with Section 66018 of the California Government  
27 Code.

28 Section 3. Ordinance No. C-28260 is hereby repealed.


1 Section 4. This resolution shall take effect immediately upon its adoption  
2 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

## Exhibit "A"

### Civic Center Broadway Garage and Lincoln Park Garage

30 minutes free parking  
\$1.75 per space each 20 minutes thereafter  
\$10 max/lost ticket  
\$1.75 for first 2 hours with library validation  
\$60 monthly parking permit  
\$6 - \$20 flat rate for special events (rate to be determined by the City Manager on a per event basis)

### Cedar Avenue Parking Lot

\$35 monthly parking permit  
\$6 - \$20 flat rate for special events (rate to be determined by the City Manager on a per event basis).

### On-line Sales Fee

#### *Monthly Permits:*

\$6.95 one-time registration fee  
\$ .98 cent monthly transaction fee plus 3% monthly credit card fee

#### *Special Events:*

\$ .98 cents - \$2.98 transaction fee based on event
