

**AMENDMENT NUMBER ONE TO CONTRACT NUMBER 29436      **29436****

**RE: Renewal of Contract No. 29436 for Furnishing and Delivering Petroleum Products (PA-00506, BPLB06000012)**

This Amendment to Contract is made and entered as of January 22, 2007 by and between the CITY OF LONG BEACH, a municipal corporation, and Rosemead Oil Products Inc (Contractor)

Contract No. 29436 is amended by mutual agreement of the parties and as indicated below by a check or other mark preceding the appropriate amendment:

- 1. The term is extended to January 19, 2008.
- 2. \$42,200 has been added to the 1st renewal term for a total "not to exceed" amount of \$84,400.
- 3. Prices during this period shall remain firm.

- 5. The price for certain items shall be decreased as shown on Exhibit "A", which is attached hereto and incorporated herein by this reference.

- 8. The locations identified on Exhibit "B", which is attached hereto and incorporated herein by this reference, are hereby added to the Contract.
- 9. Current permits, licenses, insurance and other required information are enclosed as Addendum No. 1.

Except as expressly amended above, all terms and conditions in this Contract are ratified and confirmed and remain in full force and effect. Executed with all formalities required by law as of the date first stated above.
