Subject: **Transfer of Funds: Long Beach Public Library Foundation**

RECOMMENDATION:

Increase appropriations in the General Fund Group in the City Manager Department by \$300, offset by the Seventh Council District One-time District Priority Funds, transferred from the Citywide Activities Department to the Long Beach Public Library Foundation to support the annual Librarian Appreciation Event on August 18, 2023; and,

Decrease appropriations in the General Fund Group by \$300 to offset a transfer to the City Manager Department.

DISCUSSION:

Since 1996, the Long Beach Public Library Foundation has fundraised and advocated for equal access to literacy, education, technology, and essential community resources through the Long Beach Public Library.

Councilmember Roberto Uranga would like to support the foundation's Librarian Appreciation event on August 18, 2023.

This matter has been reviewed by Budget Analyst Joe R. Guerrero on July 11, 2023.

FISCAL IMPACT

This recommendation requests the City Manager to provide funds to the Long Beach Public Library Foundation to support the annual Librarian Appreciation Event as written above. The total appropriation increase of \$300 in the General Fund Group in the City Manager Department will be offset by a decrease of appropriation of Seventh Council District One-Time District Priority funds in the General Fund Group in the Citywide Activities Department. This recommendation is anticipated to have minimal impact on staff hours beyond the budgeted scope of duties and a minimal impact on existing Council priorities.
