## RESOLUTION NO. RES-10-0138

A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH CHANGING THE NAME OF
CERRITOS DRIVE BETWEEN SAN ANTONIO DRIVE AND
ORANGE AVENUE TO LE PARK DRIVE; AND AUTHORIZE
CITY MANAGER TO DIRECT THE PUBLIC WORKS
DIRECTOR TO CHANGE MAPS AND STREET SIGNS AS
NECESSARY

The City Council of the City of Long Beach resolves as follows:

Section 1. The name of Cerritos Drive between San Antonio Drive and Orange Avenue shall be officially changed to Le Park Drive.

The portion of the street or public way involved is shown on the attached diagram marked Exhibit "A" and by this reference made a part hereof.

Section 2. The City Manager is hereby authorized to direct the Director of Public Works to change maps and street signs as necessary.

Section 3. The City Clerk shall record this resolution with the Los Angeles County Registrar/Recorder and shall transmit certified copies of this resolution to the following agencies: Los Angeles County Board of Supervisors, Los Angeles County Clerk, Los Angeles County Registrar of Voters, Los Angeles County Assessor, and Los Angeles County Surveyor. In addition, certified copies of the resolution shall be sent to the Postmaster of the City of Long Beach and to the State Board of Equalization, Sacramento, California.

Section 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.


