SECOND AMENDMENT TO AGREEMENT NO. 35584

35584

THIS SECOND AMENDMENT TO AGREEMENT NO. 35584 is made and entered, in duplicate, as of October 18, 2021, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 23, 2020, by and between THE KENNARD DEVELOPMENT GROUP DBA KDG CONSTRUCTION CONSULTING, a California corporation ("Consultant"), with a place of business at 1025 N. Brand Blvd., Suite 300, Glendale, California 91202, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35584 (the "Agreement") whereby Consultant agreed to provide as-needed engineering construction management services for various development projects at the Long Beach Airport; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to update the fee schedule; and

WHEREAS, the Parties desire to add \$90,000 to the Agreement for a total not to exceed amount of \$1,390,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows.

"A. Consultant shall furnish specialized services described in Request for Qualifications Number AP19-132, attached to this Agreement as Exhibit "A-1" and incorporated by this reference; and more particularly described in the Statement of Qualifications, attached to this Agreement as Exhibit "A-2" and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in an amount not to exceed One Million Three Hundred Ninety Thousand Dollars (\$1,390,000), at the rates or charges shown in Exhibit "B"
