RECOMMENDATION:

Adopt the attached Resolution to temporarily close and remove from public use a portion of Shoreline Drive in connection with the 2013 Long Beach Lesbian and Gay Pride Parade and Festival. (District 2)

DISCUSSION

The 30th Annual Long Beach Lesbian and Gay Pride Parade and Festival will be held in Long Beach from May 17 through 19, 2013. This event will attract over 80,000 people to the City. In order to allow for the staging of this event, a Resolution has been prepared, which provides for the temporary closure of a portion of Shoreline Drive between Ocean Boulevard and Shoreline Village Drive. This area will be used as part of the venue for the festival, which will also be held on the Marina Green and at Rainbow Lagoon Park. Additional space is required for the safety of event attendees due to projected attendance figures.

Access to the Shoreline Marina and Shoreline Village will be via Shoreline Village Drive. Directional signage shall be provided to clearly direct traffic to these areas. The appropriate City Departments have reviewed the requested closure plans.

Traffic management and signage plans shall be forwarded to newspapers serving the greater Long Beach area asking for their cooperation to publicize these plans as a public service during the weeks before the event.

This matter was reviewed by Deputy City Attorney Richard Anthony on January 14, 2013, and Budget Management Officer Victoria Bell on January 11, 2013.

TIMING CONSIDERATIONS

City Council action is requested on March 5, 2013, to expedite the execution of the Resolution in time for the event, which is scheduled for May 17 through 19, 2013.

10 The City Council of the City of Long Beach resolves as follows:

11 Section 1. The City Council of the City of Long Beach finds and
12 determines that the temporary closing of the streets described herein is necessary for the
13 safety and protection of the participants and spectators in the 2013 Lesbian and Gay
14 Pride Festival and Parade to be held from May 17, 2013 through May 19, 2013.

15 Section 2. For the conduct of the 2013 Long Beach Lesbian and Gay
16 Pride Festival and Parade, the following streets are hereby temporarily closed for the
17 periods stated:

18 A. The westbound lanes of Shoreline Drive south of Ocean
19 Boulevard and east of Shoreline Village Drive from Thursday, May 16, 2013
20 at 10:00 a.m. to Monday, May 20, 2013 at 10:00 a.m.

21 B. The eastbound lanes of Shoreline Drive between Shoreline
22 Village Drive and the entrance to the Alamitos Beach parking lot from
23 Thursday, May 16, 2013 at 7:00 p.m. to Monday, May 20, 2013 at 10:00
24 a.m.

25 Section 3. The City Manager is authorized and directed to post notices of
26 the intent to temporarily close the streets described in Section 2 above at least twenty-
27 four (24) hours prior to the closure thereof.

28 Section 4. This resolution shall take effect immediately upon its adoption
