WHEREAS, the parties entered Contract No. 29274 as of April 1, 2005 for Contractor to provide professional services for the maintenance and management of environmentally sensitive areas as identified in Contract No. 29274; and

WHEREAS, Contract No. 29274 provided for a one-year term, with two one-year options for renewal at the sole discretion of the City; and

WHEREAS, the City desires to extend the term of the Contract;

NOW, THEREFORE, in consideration of the mutual terms and conditions in Contract No. 29274, the parties agree as follows:

- 1. Section 2 of Contract No. 29274 is hereby amended in its entirety to read as follows:
- "2. The term of this Agreement shall commence on April 1, 2007 and shall end on March 31, 2008, provided, however, that City shall have the right to terminate this Agreement without penalty and without cause by giving thirty (30) days prior notice to Contractor."
- Except as expressly amended herein, all of the terms and conditions of Contract No. 29274 are ratified and confirmed and shall remain in full force and effect.
