1 THIRTY-SIXTH AMENDMENT TO AGREEMENT NO. 23214 **23214**

3 THIS THIRTY-SIXTH AMENDMENT TO AGREEMENT NO. 23214 is made
4 and entered, in duplicate, as of February 2, 2023, pursuant to a minute order adopted by
5 the City Council of the City of Long Beach at its meeting on February 8, 2022, by and
6 between CENTRALSQUARE TECHNOLOGIES, LLC, a Delaware corporation, formerly
7 known as TRITECH SOFTWARE SYSTEMS, a California corporation, formerly known as
8 TIBURON, INC., a Virginia corporation, formerly known as COMPUDYNE-PUBLIC
9 SAFETY & JUSTICE, INC., with a place of business at 1000 Business Center Drive, Lake
10 Mary, Florida 32746 ("CentralSquare") and the CITY OF LONG BEACH, a municipal
11 corporation ("City").

12 WHEREAS, City and Tiburon (the "Parties") entered into Agreement No.
13 23214 whereby Tiburon agreed to provide specialized data processing services to
14 Computer Aided Dispatch ("CAD") and Record Management Systems for City's Police and
15 Fire Departments ("Project") and to grant a license and maintenance for the Project; and

16 WHEREAS, in 2015 Trittech Software Systems acquired Tiburon, Inc.; and
17 WHEREAS, in 2018, Trittech, Inc. merged with CentralSquare Technologies,
18 LLC; and

19 WHEREAS, the Parties have entered into thirty-five amendments to
20 Agreement No. 23214; and

21 WHEREAS, the Parties desire to amend the Agreement to extend the term
22 one (1) additional one-year period, add \$424,970.98 to the extension, for a total not to
23 exceed Contract amount of \$3,848,981.20, and attach an updated rate sheet;

24 NOW, THEREFORE, in consideration of the mutual terms, covenants and
25 conditions in Agreement No. 23214 and herein contained, the Parties agree as follows:

26 1. The term for support and maintenance of the Computer-Aided
27 Dispatch Software and Records Management System is hereby extended beginning on
28 March 1, 2022 and ending on February 28, 2024. The term may be extended for one (1)

1 additional one-year period, at the discretion of the City Manager.

2 2. Notwithstanding anything to the contrary in the Agreement, previous
3 amendments, attachments or exhibits, CentralSquare shall provide software support
4 services described on Exhibit "A", attached to this Thirty-Sixth Amendment and
5 incorporated by this reference, for an additional twelve-month term through February 28,
6 2024, and City shall pay for these services during the extension an amount not to exceed
7 Four Hundred Twenty-Four Thousand Nine Hundred Seventy Dollars and Ninety-Eight
8 Cents (\$424,970.98), for a total not to exceed Contract amount of Three Million Eight
9 Hundred Forty-Eight Thousand Nine Hundred Eighty-One Dollars and Twenty Cents
10 (\$3,848,981.20).

11 3. Except as expressly amended in this Thirty-Sixth Amendment, all
12 terms and conditions in Agreement No. 23214 are ratified and confirmed and shall remain
13 in full force and effect.
