

1 FIRST AMENDMENT TO AGREEMENT NO. 31342

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 31342 is made and
4 entered, in duplicate, as of February 24, 2010 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 December 16, 2008, by and between THE REGENTS OF THE UNIVERSITY OF
7 CALIFORNIA, a California corporation ("Consultant"), with a place of business at 11000
8 Kinross Avenue, Suite #102, Los Angeles, California 90095-1406, and the CITY OF
9 LONG BEACH, a municipal corporation ("City").

10 WHEREAS, the City has received grant funding from the Department of
11 Homeland Security under the Urban Area Security Initiative (UASI) program to use for
12 homeland security purposes; and

13 WHEREAS, the parties entered Agreement No. 31342 wherein Consultant
14 agreed to provide specialized services requiring unique skills to be performed in
15 connection with the development and implementation of a Public Health Training and
16 Education Academy ("Project"), which is one of the deliverables to be developed using
17 the grant funds; and

18 WHEREAS, the parties desire to extend the term of the Agreement;

19 NOW, THEREFORE, in consideration of the mutual terms and conditions in
20 Agreement No. 31342 and herein, the parties agree as follows:

21 1. Section 2 of Agreement No. 31342 is hereby amended to read as
22 follows:

23 "2. TERM. The initial term of this Agreement shall commence at
24 midnight on July 1, 2009, and shall terminate at 11:59 p.m. on September 30, 2010. The
25 extended term of this Agreement shall commence at midnight on October 1, 2010, and
26 shall terminate at 11:59 p.m. on January 31, 2011, unless sooner terminated as provided
27 in this Agreement, or unless the services or the Project is completed sooner."

28 2. Except as expressly amended herein, all terms and conditions in

1 Agreement No. 31342 are ratified and confirmed and shall remain in full force and effect.
2 IN WITNESS WHEREOF, the parties have caused this document to be duly
3 executed with all formalities required by law as of the date first stated above.
