## FIRST AMENDMENT TO AGREEMENT NO. 31342

THIS FIRST AMENDMENT TO AGREEMENT NO. 31342 is made and entered, in duplicate, as of February 24, 2010 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on December 16, 2008, by and between THE REGENTS OF THE UNIVERSITY OF CALIFORNIA, a California corporation ("Consultant"), with a place of business at 11000 Kincross Avenue, Suite #102, Los Angeles, California 90095-1406, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City has received grant funding from the Department of Homeland Security under the Urban Area Security Initiative (UASI) program to use for homeland security purposes; and

WHEREAS, the parties entered Agreement No. 31342 wherein Consultant agreed to provide specialized services requiring unique skills to be performed in connection with the development and implementation of a Public Health Training and Education Academy ("Project"), which is one of the deliverables to be developed using the grant funds; and

WHEREAS, the parties desire to extend the term of the Agreement;

NOW, THERFORE, in consideration of the mutual terms and conditions in Agreement No. 31342 and herein, the parties agree as follows:

- 1. Section 2 of Agreement No. 31342 is hereby amended to read as follows:
- "2. <u>TERM.</u> The initial term of this Agreement shall commence at midnight on July 1, 2009, and shall terminate at 11:59 p.m. on September 30, 2010. The extended term of this Agreement shall commence at midnight on October 1, 2010, and shall terminate at 11:59 p.m. on January 31, 2011, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
  - 2. Except as expressly amended herein, all terms and conditions in
