FIRST AMENDMENT TO AGREEMENT NO. 36397
36397

THIS FIRST AMENDMENT TO AGREEMENT NO. 36397 is made and entered, as of June 21, 2023 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 20, 2023, by and between INNOVATIVE DESIGN AND SHEET METAL PRODUCTS, INC., dba INNOVATIVE EMERGENCY EQUIPMENT, a Delaware corporation ("Contractor"), whose address is 1616 Marlborough Avenue, S1, Riverside, CA 92507, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services to provide new vehicle preparation services and component preassembly for Police and Fire Department vehicles; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 36397 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties desire to extend the term of the Agreement until the RCSD Contract expires on September 30, 2024, and increase the contract amount;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows.

"A. Contractor shall provide new vehicle preparation services and component preassembly for Police and Fire Department vehicles of the same kind identified in the RCSD Contract, in an annual amount not to exceed Ninety-Five Thousand Dollars (\$95,000). The term of this Agreement shall commence at midnight on August 1, 2022, and shall terminate at 11:59 p.m. on July 30, 2024, unless sooner terminated as provided in this Agreement. To the extent that the RCSD Contract and this Agreement are inconsistent, the following priority shall govern: (1) this Agreement and (2) the RCSD Contract."


2. Except as expressly modified herein, all of the terms and conditions

2 and effect.


