3 THIS THIRD AMENDMENT TO AGREEMENT NO. 34903 is made and  
4 entered, in duplicate, as of February 8, 2022, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 February 1, 2022, by and between HOMEBOY RECYCLING, a California social purpose  
7 corporation dba Homeboy Electronics Recycling ("Contractor"), with a place of business at  
8 130 W. Bruno Street, Los Angeles, California 90012, and the CITY OF LONG BEACH, a  
9 municipal corporation ("City").

10 WHEREAS, City and Contractor (the "Parties") entered into Agreement No.  
11 34903 (the "Agreement") whereby Contractor agreed to provide transportation and  
12 disposal services of electronic waste; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to  
14 extend the term to February 28, 2021; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement  
16 to extend the term to February 28, 2022

17 WHEREAS, the Parties desire to extend the term to November 30, 2022;

18 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
19 conditions herein contained, the Parties agree as follows:

20 1. Section 2 of the Agreement is hereby amended to read as follows:

21 "2. TERM. The term of this Agreement shall commence at midnight on  
22 March 1, 2018, and shall terminate at 11:59 p.m. on November 30, 2022, unless sooner  
23 terminated as provided in this Agreement, or unless the services or the Project is  
24 completed sooner."

25 2. Except as expressly amended herein, all terms and conditions in  
26 Agreement No. 34903 are ratified and confirmed and shall remain in full force and effect.






