A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE A CONTRACT WITH FASTENAL COMPANY ON THE SAME TERMS AND CONDITIONS AFFORDED TO REGIONAL 4 EDUCATION SERVICE CENTER THROUGH THE COOPERATIVE PURCHASING NETWORK, FOR AN ANNUAL AMOUNT NOT TO EXCEED \$223,000

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City Manager to enter into a contract on behalf of the City, in writing or otherwise, without advertising for bids, for services, supplies, materials, equipment or labor, with other government agencies, when authorized by resolution; and

WHEREAS, the City desires to purchase fasteners and miscellaneous hardware; and

WHEREAS, Region 4 Education Service Center through The Cooperative Purchasing Network has a contract with Fastenal Company for the purchase of fasteners and miscellaneous hardware, Contract No. R142101 ("TCPN Contract"); and

WHEREAS, the City's participation in the TCPN Contract will facilitate acquisition of the fasteners and miscellaneous hardware as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the TCPN Contract considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The City Manager or designee is hereby authorized to enter a

1 contract with Fastenal Company for fasteners and miscellaneous hardware, in an annual
2 amount not to exceed Two Hundred Twenty-Three Thousand Dollars (\$223,000), for a
3 period of one (1) year, with the option to extend the term for two (2) additional one-year
4 periods, at the discretion of the City Manager.


5 Section 2. This resolution shall take effect immediately upon its adoption
6 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
