- 3. Subgrant Summary. Subgrant Term. Delete in its entirety the end date "December 31, 2019" and replace it with the date "June 30, 2020."
- 4. Part I. Subgrant Schedule. Article 2. Term. Delete in its entirety the end date "December 31, 2019" and replace it with the date "June 30, 2020."
- 5. Part I. Subgrant Schedule. Article 6. Reports and Report Schedule. Section (iii). Schedule. Delete the table in Section (iii) in its entirety and replace as follows:
