## SECOND AMENDMENT TO PERMIT NO. 30285

## 

THIS SECOND AMENDEMENT TO PERMIT NO. 30285 is made and entered, in duplicate, as of April 23, 2012 for reference purposes only, pursuant to minute order adopted by the City Council of the City of Long Beach at its meeting on June 19, 2007.

WHEREAS, in 2007, the parties executed a five (5) year Permit wherein the City permitted Permittee to use and occupy portions of the docks, slips and end ties at Rainbow Harbor; and

WHEREAS, the parties desire to execute the option to extend the Permit for an additional two (2) years;

NOW, THEREFORE, in consideration of the mutual terms, covenants and conditions in Permit No. 30285 and herein, the parties agree as follows:

- 1. Section 3 of Permit No. 30285 is deleted and amended in its entirety to read as follows:
- "3. <u>TERM</u>: The term of this Permit shall commence at 12:01 a.m. on May 15, 2007 and shall terminate at midnight on June 30, 2014. Notwithstanding the foregoing, either party may terminate this Permit at any time for any or no reason upon ninety (90) days written notice to the other party. Upon termination of this Permit (whether by lapse of time or otherwise), Permittee shall quit and surrender possession of the Permit Area and remove its personal property therefrom."
- 2. Section 4.1 of Permit No. 30285 is deleted and amended in its entirety to read as follows:

## "4.1. COMPENSATION:

4.1. Dock Fee. Permittee shall pay to the City for the use of the Permit Area an amount equal to Sixteen Dollars (\$16.00) per lineal foot, per month, or other fee subsequently adopted by the City Council of the City of Long Beach, occupied and/or reserved by Permittee for any time such slip or end tie is so used. The Dock Fee shall be

- 3. Section 4.2.(B) of Permit No. 30285 is deleted and amended in its entirety to read as follows:
- "4.2.(B) In the event that the five (5) percent of gross receipts derived from Permittee's Long Beach Operations paid by Permittee to City does not exceed Four Thousand Two Hundred Eighty-Five Dollars (\$4,285.00) for each calendar year ("Minimum Payment"), then Permittee shall pay to City the difference between Four Thousand Two Hundred Eighty Five Dollars (\$4,285.00) and the amount of Permit Fees paid during the calendar year on or before January 31 of each year."
- 4. Except as expressly amended herein, all of the terms, covenants, and conditions in Permit No. 30285 are ratified and confirmed and shall remain in full force and effect.
