3 THIS SECOND AMENDMENT TO AGREEMENT NO. 34129 is made and
4 entered, in duplicate, as of August 7, 2019 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 November 17, 2015, by and between JOHNSON-FRANK & ASSOCIATES, INC., a
7 California corporation (“Consultant”), with a place of business at 5150 E. Hunter Avenue,
8 Anaheim, California 92807, and the CITY OF LONG BEACH, a municipal corporation
9 (“City”).

10 WHEREAS, City and Consultant (the “Parties”) entered into Agreement No.
11 34129 (the “Agreement”) whereby Consultant agreed to provide as-needed surveying
12 services (“Project”); and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 extend the term to December 31, 2019; and

15 WHEREAS, the Parties desire to extend the term one (1) additional one-year
16 period;

17 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
18 conditions herein contained, the Parties agree as follows:

19 1. Section 2 of the Agreement is hereby amended to read as follows:

20 “2. TERM. The term of this Agreement shall commence at midnight on
21 January 1, 2016, and shall terminate at 11:59 p.m. on December 31, 2020, unless sooner
22 terminated as provided in this Agreement, or unless the services or the Project is
23 completed sooner. The Parties have no further options to extend the term.”

24 2. Except as expressly amended herein, all terms and conditions in
25 Agreement No. 34129 are ratified and confirmed and shall remain in full force and effect.
