WHEREAS, reference is made to that certain document entitled "Sub-Award Agreement by and between Los Angeles County Health Agency and the City of Long Beach for the Los Angeles County Law Enforcement Assisted Diversion (LEAD) Program," dated May 1, 2017, and further identified as Agreement No. H-707337, and any amendments thereto (all hereafter referred to as "Agreement") and,

WHEREAS, on April 18, 2017, the Board of Supervisors delegated authority to the Los Angeles County Health Agency to execute amendments to the sub-award agreement(s); and

WHEREAS, it is the intent of the parties hereto to amend Agreement to extend the term of the Agreement for the period of May 1, 2017 through December 31, 2021; and

WHEREAS, Agreement provides that changes in accordance with Sub-paragraph 8.1, AMENDMENTS, may be made in the form of an Amendment which is formally approved and executed by the parties; and

NOW, THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:

1. This Amendment shall be effective upon execution.
2. The Agreement is hereby incorporated by reference, and all of its terms and conditions, including capitalized terms defined herein, shall be given full force and effect as if fully set forth herein.
3. The Agreement, Paragraph 4.0 – Term of Agreement, is deleted in its entirety and replaced to read as follows:

"4.0 TERM OF AGREEMENT

The term of this Agreement shall commence on May 1, 2017 and shall expire on December 31, 2021, unless sooner terminated or extended, in whole or in part, as provided in this Agreement."

4. Except for the changes set forth hereinabove, Agreement shall not be changed in any respect by this Amendment.





