## THIRD AMENDMENT TO AGREEMENT NO. 34271

THIS THIRD AMENDMENT TO AGREEMENT NO. 34271 is made and entered, in duplicate, as of June 28, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on February 5, 2019, by and between DENTONS US LLP, a Delaware limited liability partnership ("Consultant"), with a place of business located at 1900 K Street NW, Washington DC 20006-1102, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, representation of City's interests and liaison between City and other officials, agencies, bodies, commissions, committees and organizations require the assistance of personnel experienced in such matters; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34271 (the "Agreement") whereby Consultant agreed to provides these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to February 28, 2018; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to February 28, 2019; and

WHEREAS, the Parties desire to extend the term one (1) additional two-year
