Subject: Proposed Schedule for Fiscal Year 2007 Community Input, Budget Workshops and Budget Oversight Committee Meetings

The City Charter requires that the City Manager submit the Proposed Budget for Fiscal Year 2007 (FY 07) to the Mayor on or before August 1, 2006. The City Charter also requires that the Mayor transmit the budget to the City Council along with recommendations no later than August 15, 2006. As you are aware, the City Manager is committed to presenting the Mayor and City Council with a structurally-balanced FY 07 General Fund budget. However, in order to achieve this goal, difficult decisions must be formulated over the coming weeks and months. Moreover, the City Manager is making every attempt to present the Proposed Budget for FY 07 on an earlier schedule in order that fuller City Council and community input can be encouraged. Therefore, in addition to the City Council workshop scheduled for June 13, as well as monthly Budget Oversight Committee (BOC) meetings, several additional opportunities to continue the budget dialogue have been developed through community presentations, City Council budget workshops, BOC meetings and budget hearings. The following chart provides the proposed schedule for input and deliberation regarding the Proposed Budget FY 07:
