3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH DESIGNATING THE CITY OF
5 LONG BEACH AS THE ADMINISTERING AGENCY AND
6 SIGNATORY AUTHORITY FOR THE LOCAL
7 WORKFORCE INVESTMENT ACT PROGRAMS AND
8 DESIGNATING THE WORKFORCE INVESTMENT BOARD
9 TO PROVIDE POLICY GUIDANCE AND OVERSIGHT FOR
10 THE PROGRAM

12 WHEREAS, the City of Long Beach has received notification of a formula
13 allocation of \$5,202,098.00 from the State of California, Employment Development
14 Department ("State"), to provide workforce development services for residents and
15 businesses (the "Program"); and

16 WHEREAS, in order to participate in the Program the State requires that a
17 resolution of the City Council be adopted which designates the administering agency and
18 signatory authority for the Program.

19 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
20 follows:

21 Section 1. The City of Long Beach shall be the administering agency and
22 signatory authority for the Program.

23 Section 2. The City Council of the City of Long Beach designates the
24 Workforce Investment Board to provide policy guidance and oversight for the Program.

25 Section 3. The City Council of the City of Long Beach acknowledges that
26 the City shall be responsible to the State of California, Employment Development
27 Department, for the expenditure of all funds and liable for those funds not expended in
28 accordance with the Program, and shall return such funds to the State of California,

1 Employment Development Department.

2 Section 4. The City Council of the City of Long Beach authorizes the City
3 Manager or his designee to execute all documents necessary for the implementation of
4 the Program, including, but not limited to, plans, modifications, adjustments, grant
5 applications, grants, subgrant agreements, and other contracts.

6 Section 5. This Resolution shall take effect immediately upon its adoption
7 by the City Council, and the City Clerk shall certify to the vote adopting this Resolution.


