SECOND AMENDMENT TO AGREEMENT NO. 34520

34520

THIS SECOND AMENDMENT TO AGREEMENT NO. 34520 is made and entered, in duplicate, as of June 12, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 11, 2019, by and between CARAHSOFT TECHNOLOGY CORP., a Maryland corporation, with a place of business at 1860 Michael Faraday Drive, Suite 100, Reston, Virginia 20190 ("Contractor"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 34520 (the "Agreement") whereby Contractor agreed to provide, install, train and support City staff in the use and implementation of a new service management application; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to February 28, 2020 and add the authorized amount of \$68,040 to the extension; and

WHEREAS, the Parties desire to increase the annual not to exceed amount to \$110,565 and extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A of the Agreement is hereby amended to read as follows:

"A. Contractor shall furnish specialized services more particularly described in Exhibit "A-2", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Two Hundred Fifty-Two Thousand Nine Hundred Twenty-Nine Dollars (\$252,929) for the term ending February 28, 2018; Sixty-Eight Thousand Forty Dollars (\$68,040) for the term ending February 28, 2019; and One Hundred Ten Thousand Five Hundred Sixty-Five Dollars (\$110,565) annually thereafter, at the rates or charges shown in Exhibit "A-2"."

2. Section 2 of the Agreement is hereby amended to read as follows:

1 "2. TERM. The term of this Agreement shall commence at midnight on
2 March 1, 2017, and shall terminate at 11:59 p.m. on February 28, 2021, unless sooner
3 terminated as provided in this Agreement, or unless the services or the Project is
4 completed sooner."

5 3. Except as expressly stated herein, all of the terms and conditions of
6 Agreement No. 34520 are ratified and confirmed and shall remain in full force and effect.
