ORDINANCE NO. ORD-13-0019

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY AMENDING SUBSECTIONS 10.12.010.A.54, 10.12.010.A.69, 10.12.020.A.14, AND 10.12.020.A.22; BY ADDING SUBSECTIONS 10.12.020.A.68 AND 10.12.020.A.69, ALL RELATING TO SPEED LIMITS

The City Council of the City of Long Beach ordains as follows:

Section 1. Subsection 10.12.010.A.54 of the Long Beach Municipal

Code is amended to read as follows:

54. Stearns Street:

- a. Redondo Avenue to Clark Avenue, thirty (30) miles per hour,
- b. Clark Avenue to Marwick Avenue, thirty (30) miles per hour,
- c. Palo Verde Avenue to Studebaker Road, thirty-five (35) miles per hour,
- d. Studebaker Road to Stevely Avenue, thirty (30) miles per hour;

Section 2. Subsection 10.12.010.A.69 of the Long Beach Municipal

Code is amended to read as follows:

69. Termino Avenue:

- a. Seventh Street to Anaheim Street, twenty-five (25) miles per hour,
- b. Anaheim Street to Hathaway Avenue, twenty-five (25) miles

3 Section 3. Subsection 10.12.020.A.14 of the Long Beach Municipal

4 Code is amended to read as follows:

5 14. Conant Street:

6 a. Lakewood Boulevard to Clark Avenue, thirty (30) miles per

8 b. Heinemann Avenue to Lakewood Boulevard, thirty-five (35)


6 Section 7. The City Clerk shall certify to the passage of this ordinance
