THIS FIRST AMENDMENT TO AGREEMENT NO. 35862 is made and entered, in duplicate, as of March 4, 2022 for reference purposes only, pursuant to Resolution No. RES-21-0010, adopted by the City Council of the City of Long Beach at its meeting on February 9, 2021, by and between CARAHSOFT TECHNOLOGY CORP., a Maryland corporation ("Contractor"), whose address is 11493 Sunset Hills Road, Suite 100, Reston, Virginia 20190, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35862 (the "Agreement") whereby Contractor agreed to provide annual licensing and maintenance of the City's service management application, ServiceNow; and

WHEREAS, the Parties desire to include the contingency language;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows:

A. Contractor shall furnish specialized services more particularly described in Exhibit "A", attached to the Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in an annual amount of One Hundred Ten Thousand Five Hundred Sixty-Five Dollars (\$110,565), with a twenty percent (20%) contingency in the amount of Twenty-Two thousand One Hundred Thirteen Dollars (\$22,113), for a total annual contract amount not to exceed One Hundred Thirty-Two Thousand Six Hundred Seventy-Eight Dollars (\$132,678) at the rates or charges shown in Exhibit "A".

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35862 are ratified and confirmed and shall remain in full force and effect.
