

1 SEVENTH AMENDMENT TO AGREEMENT NO. 34385

3 THIS SEVENTH AMENDMENT TO AGREEMENT NO. 34385 is made and
4 entered, in duplicate, as of April 30, 2020, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on July 5, 2016,
6 by and between PSOMAS, a California corporation ("Consultant"), with a place of business
7 at 3 Hutton Centre Drive, Suite 200, Santa Ana, California 92707, and the CITY OF LONG
8 BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 34385 (the "Agreement") whereby Consultant agreed to provide as-needed public works
11 construction management and inspection services; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to
13 add \$1,000,000 for a total not to exceed amount of \$2,000,000; and

14 WHEREAS, the Parties entered into a Second Amendment to the Agreement
15 to add \$1,000,000 for a total not to exceed amount of \$3,000,000; and

16 WHEREAS, the Parties entered into a Third Amendment to the Agreement
17 to add \$700,000 for a total not to exceed amount of \$3,700,000; and

18 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
19 to add \$1,000,000 for a total not to exceed amount of \$4,700,000; and

20 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to
21 add \$4,000,000 for a total not to exceed amount of \$8,700,000; and

22 WHEREAS, the Parties entered into a Sixth Amendment to the Agreement
23 to add \$1,000,000 for a total not to exceed amount of \$9,700,000 and extend the term to
24 August 31, 2020; and

25 WHEREAS, the Parties desire to extend the term one (1) additional one year
26 period;

27 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
28 conditions herein contained, the Parties agree as follows:


1 1. Section 2 of the Agreement is hereby amended to read as follows:

2 "2. TERM. The term of this Agreement shall commence at midnight on
3 August 31, 2016, and shall terminate at 11:59 p.m. on August 31, 2021, unless sooner
4 terminated as provided in this Agreement, or unless the services or the Project is
5 completed sooner."

6 2. Except as expressly modified herein, all of the terms and conditions
7 contained in Agreement No. 34385 are ratified and confirmed and shall remain in full force
8 and effect.


