3 AN ORDINANCE OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AMENDING THE LONG BEACH  
5 MUNICIPAL CODE BY AMENDING SECTION 10.22.080  
6 BY ADDING SUBSECTION BB RELATING TO PARKING  
7 VEHICLES FOR SALE  
8

9 WHEREAS, the City has received numerous complaints from citizens  
10 regarding the parking of vehicles with "For Sale" signs on Bayshore Avenue between  
11 Appian Way and 2<sup>nd</sup> Street, on 2<sup>nd</sup> Street between Bayshore Avenue and Naples Plaza  
12 and on Colorado Street between Nieto Avenue and Bellflower Boulevard; and

13 WHEREAS, with the increase of vehicles parking with "for sale" signs on  
14 them in the areas described above, such activity is creating unsafe traffic conditions  
15 because motorists interrupt traffic flow to stop or slow down to observe the vehicles  
16 displaying "for sale" signs which creates the potential for traffic collisions.

17 NOW THEREFORE, the City Council of the City of Long Beach ordains as  
18 follows:

20 Section 1. Section 10.22.080 of the Long Beach Municipal Code is  
21 hereby amended by adding Subsection BB to read as follows:

22 BB. Bayshore Avenue between Appian Way and 2<sup>nd</sup> Street, on 2<sup>nd</sup>  
23 Street between Bayshore Avenue and Naples Plaza and on Colorado  
24 Street between Nieto Avenue and Bellflower Boulevard.

26 Sec. 2. The City Clerk shall certify to the passage of this ordinance by the  
27 City Council and cause the same to be posted in three conspicuous places in the City  
28 of Long Beach, and it shall take effect on the thirty-first day after it is approved by the


