## FOURTH AMENDMENT TO CLINICAL AFFILIATION AGREEMENT NO. 26058

## 26058

This Fourth Amendment to Agreement No. 26058 is authorized pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on November 14, 2006, between LONG BEACH MEMORIAL MEDICAL CENTER (hereinafter "LBMMC"), and the CITY OF LONG BEACH (hereinafter "City"), collectively referred to as the "parties."

WHEREAS, the City provides approved programs in health care education including, but not limited to, EMT-I and EMT-Paramedic training, which requires clinical experience for participants enrolled in these programs; and

WHEREAS, LBMMC owns and operates as acute care hospital and ancillary facilities that are appropriate for furnishing such experience; and

WHEREAS, it has mutually benefitted LBMMC and City to allow the employees and students of City's program to use LBMMC facilities for their field experience; and

WHEREAS, the parties now desire to amend Agreement No. 26058 to extend the term.

NOW, THEREFORE, it is agreed as follows:

- 1. Section 6 of Agreement No. 26058 is hereby amended in its entirety to read as follows:
  - "6. TERM; TERMINATION.

This Agreement is for a term of two (2) years commencing on January 1, 2009 and it may be renewed for an additional two (2) years subject to the approval of LBMMC and the City Manager of Long Beach.

This Agreement may be terminated by either party, acting with or without cause by giving written notice of termination thirty (30) days prior to the end of a semester."
