

SECOND AMENDMENT TO AGREEMENT NO. 33265

THIS SECOND AMENDMENT TO AGREEMENT NO. 33265 is made and entered, in duplicate, as of December 31, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on March 20, 2018, by and between CHARTER COMMUNICATIONS OPERATING, LLC DBA TIME WARNER CABLE ENTERPRISES, LLC, a Delaware limited liability company ("TWC"), with a place of business at 17777 Center Court Drive, 8th Floor, Cerritos, California 90703, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and TWC (the "Parties") entered into Agreement No. 33265 (the "Agreement") whereby TWC agreed to provide local and long distance telephone, data communications, and internet services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to November 14, 2019; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period and add \$500,000 for a total not to exceed Agreement amount of \$1,346,303.97;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. The term of the Agreement shall be extended commencing at 12:01 a.m. on November 15, 2019, and shall terminate at 11:59 p.m. on November 14, 2020, unless sooner terminated as provided in this Agreement, or unless the services to be performed or the Project is completed sooner.

2. \$500,000 is added to the Contract for a total not to exceed Contract amount of \$1,346,303.97.

3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33265 are ratified and confirmed and shall remain in full force and effect.




