3 THIS FIRST AMENDMENT TO INDEPENDENT CONTRACTOR  
4 AGREEMENT NO. 36116 ("First Amendment") is made and entered, in duplicate, as of  
5 September 7, 2021 for reference purposes only, pursuant to a minute order adopted by the  
6 City Council of the City of Long Beach at its meeting on October 5, 2021 by and between  
7 JOHN GROSS, DBA FINANCIAL MANAGEMENT AND SYSTEMS CONSULTING, an  
8 Independent Contractor, with a place of business located at 5652 E. Grandview Road,  
9 Scottsdale, AZ 85254 ("Consultant"), and the CITY OF LONG BEACH, a municipal  
10 corporation ("City").

11 WHEREAS, City requires specialized services requiring unique skills to be  
12 performed in connection with Special Projects within the Financial Management  
13 Department (the "Project"); and

14 WHEREAS, City and Consultant (the "Parties") entered into Independent  
15 Contractor Agreement No. 36116 (the "Agreement") whereby Consultant agreed to provide  
16 these services; and

17 WHEREAS, the Parties desire to exercise the option to renew the Agreement  
18 and extend the term for an additional six (6) months;

19 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
20 conditions in the Agreement and this First Amendment, the Parties agree as follows:

21 1. Section 2. of the Agreement is hereby amended to read as follows:

22 "2. TERM. The term of this Agreement shall commence on  
23 September 7, 2021 and, subject to the provisions of paragraph 10, shall terminate  
24 September 7, 2022."

25 2. Except as expressly modified herein, all of the terms and conditions  
26 contained in Independent Contractor Agreement No. 36116 are ratified and confirmed and  
27 shall remain in full force and effect.
