This Amendment No. One ("Amendment") to Contract AO-19-607 ("Contract") is entered into this IO day of March 2020, by and between the County of Los Angeles (hereafter "COUNTY") and City of Long Beach (hereafter referred to as "CONTRACTOR" or "CONSULTANT"), to provide the Interdepartmental Team Pilot.

WHEREAS, on March 11, 2019, the COUNTY entered into a Contract with the CONTRACTOR to provide the Interdepartmental Team Pilot to increase the City of Long Beach's capacity to address homelessness; and

WHEREAS, the COUNTY and CONTRACTOR mutually agree that it is to both of their benefit to extend the term of the Agreement from March 10, 2020 to June 30, 2020, to continue providing services detailed in the Statement of Work, at no additional cost.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and effective upon full execution, it is agreed between the parties that the Contract shall be amended as follows:

- 1. Section 4, TERM OF CONTRACT, Subsection 4.1, shall be deleted in its entirety and replaced as follows:
 - 4.1 The term of this Contract commenced on **March 11, 2019** and shall expire on **June 30, 2020**, unless sooner terminated or extended, in whole or in part as provided in this Contract.
- All other Contract terms remain in full force and effect.
