
Contract No. 34763 is amended by agreement of the parties and as indicated below by a check or other mark preceding the appropriate amendment:


- 1. 2nd renewal option for the term 10/01/2020 to 09/30/2021

- 9. Current permits, licenses, insurance and other required information are attached as Addendum No. 2.




