RECOMMENDATION:

Adopt Resolution declaring the results of the Special Municipal Election held on Tuesday, November 6, 2018. (Citywide)

DISCUSSION

As required by the California Elections Code, the City Attorney has prepared a resolution declaring the results of the Special Municipal Election held on Tuesday, November 6, 2018, to adopt Measure AAA, Authority of Long Beach City Auditor to Conduct Performance Audits; Measure BBB, City of Long Beach Term Limits Amendment; Measure CCC, City of Long Beach Ethics Commission; Measure DDD, City of Long Beach Independent Citizens Redistricting Commission; and Measure WW, Long Beach Hotel Workers Measure (Exhibit A).

As certified by the Los Angeles County Registrar-Recorder/County Clerk, the results are as follows:

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH DECLARING THE RESULTS OF THE SPECIAL MUNICIPAL ELECTION HELD IN THE CITY OF LONG BEACH, CALIFORNIA, ON TUESDAY, NOVEMBER 6, 2018, TO SUBMIT TO A VOTE OF THE QUALIFIED ELECTORS OF THE CITY FOUR CHARTER AMENDMENT BALLOT MEASURES AND ONE INITIATIVE MEASURE

WHEREAS, the City Council of the City of Long Beach did, by Resolution Nos. RES-18-0107, RES-18-0108, RES-18-0109, and RES-18-0110, duly call and provide for the holding of a Special Municipal Election on Tuesday, November 6, 2018, to submit to a vote of the qualified electors of the City four (4) Charter Amendment ballot measures; and

WHEREAS, the City Elections official, pursuant to Resolution No. RES-18-0118, determined that one (1) initiative measure, known as Proposition WW, qualified to be placed on the ballot by the requisite number of signatures and was submitted to a vote of the qualified electors of the City; and

WHEREAS, the Special Municipal Election was held in the City of Long Beach on Tuesday, November 6, 2018; and

WHEREAS, the Los Angeles County Registrar duly canvassed the returns of the election and has transmitted the results to the City Clerk;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. A true and correct copy of the canvass of the votes cast for and against the Charter Amendment ballot measures is attached as Exhibit "A" to this

2 Section 2. The Charter Amendment ballot measures appeared on the
3 ballot as follows:

4 A. Measure AAA: Authority of Long Beach City Auditor to
5 Conduct Performance Audits. Shall the City Charter be amended to
6 authorize the City Auditor to conduct performance audits, defined as
7 financial, compliance, efficiency, economy, operational, or program audits
8 or studies, of any City department, board or commission?

9 B. Measure BBB: City of Long Beach Term Limits
10 Amendment. Shall the City Charter be amended to limit the Mayor and City
11 Councilmembers to serving three terms and to prohibit individuals who have
12 already served three terms from being elected as write-in candidates?

13 C. Measure CCC: City of Long Beach Ethics Commission.
14 Shall the City Charter be amended to create an ethics commission of Long
15 Beach residents for the purpose of monitoring, administering and
16 implementing governmental ethics in the City of Long Beach?

17 D. Measure DDD: City of Long Beach Independent Citizens
18 Redistricting Commission. Shall the City Charter be amended to create an
19 independent citizens commission of Long Beach residents to determine the
20 boundaries of City Council districts every ten years after the national
21 census?

22 Section 3. The initiative measure appeared on the ballot as follows:

23 A. Measure WW: Long Beach Hotel Worker Measure.
24 Shall a ballot measure be adopted to require Long Beach hotels containing
25 more than 50 rooms to provide personal emergency contact devices for
26 hotel workers, adopt restrictions on the square footage of hotel areas which
27 may be cleaned and establish penalties for failure to comply with the
28 restrictions?

1 Section 4. It is determined and declared that at the Special Municipal
2 Election, 92,517 votes were cast in favor of Measure AAA and 37,752 votes were cast
3 against it, and that it received a majority of the votes cast and that such proposition is
4 hereby approved.

5 Section 5. It is determined and declared that at the Special Municipal
6 Election, 75,833 votes were cast in favor of Measure BBB and 57,627 votes were cast
7 against it, and that it received a majority of the votes cast and that such proposition is
8 hereby approved.

9 Section 6. It is determined and declared that at the Special Municipal
10 Election, 81,462 votes were cast in favor of Measure CCC and 50,381 votes were cast
11 against it, and that it received a majority of the votes cast and that such proposition is
12 hereby approved.

13 Section 7. It is determined and declared that at the Special Municipal
14 Election, 78,581 votes were cast in favor of Measure DDD and 51,928 votes were cast
15 against it, and that it received a majority of the votes cast and that such proposition is
16 hereby approved.

17 Section 8. It is determined and declared that at the Special Municipal
18 Election, 84,411 votes were cast in favor of Proposition WWW and 46,480 votes were
19 cast against it, and that it received a majority of the votes cast and that such proposition
20 is hereby approved.

21 Section 9. This resolution shall take effect immediately upon its adoption
22 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
