1 FIFTH AMENDMENT TO AGREEMENT NO. 34668

3 THIS FIFTH AMENDMENT TO AGREEMENT NO. 34668 is made and
4 entered, in duplicate, as of June 7, 2023, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on June 6, 2023,
6 by and between ALTA PLANNING + DESIGN, INC., a California corporation ("Consultant"),
7 with a place of business at 711 Southeast Grand Avenue, Portland, Oregon 97214, and
8 the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 34668 (the "Agreement") whereby Consultant agreed to provide as needed urban planning
11 design services for a period of two (2) years with the option to renew for three (3) additional
12 one-year periods in an amount not to exceed Six Hundred Thousand Dollars (\$600,000);
13 and; and

14 WHEREAS, the Parties entered into a First Amendment to extend the term
15 to June 30, 2020; and

16 WHEREAS, the Parties entered into a Second Amendment to increase the
17 total contract amount for a total not to exceed Seven Hundred Thousand (\$700,000), and
18 extend the term to June 30, 2021; and

19 WHEREAS, the Parties entered into a Third Amendment to extend the term
20 to June 30, 2022; and

21 WHEREAS, on June 21, 2022, City Council approved extending the
22 Agreement one (1) additional one-year period; and

23 WHEREAS, the Parties entered into a Fourth Amendment to extend the term
24 to June 30, 2023, update the City Representative, and attach an updated rate sheet; and

25 WHEREAS, on June 6, 2023, City Council approved extending the
26 Agreement term by one (1) additional one-year period; and

27 WHEREAS, the Parties desire to extend the term of the Agreement, and
28 attach an updated rates sheet;

1 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
2 conditions herein contained, the Parties agree as follows:

3 1. Section 2 of the Agreement is hereby amended to read as follows:

4 "2. TERM. The term of this Agreement shall commence at midnight on
5 July 1, 2017, and shall terminate at 11:59 p.m. on June 30, 2024, unless sooner terminated
6 as provided in this Agreement, or unless the services or the Project is completed sooner."

7 2. The Rates contained in Exhibit "B-1" in the Fourth Amendment to the
8 Agreement are hereby amended and replaced by Exhibit "B-2", attached hereto and
9 incorporated herein.

10 3. Except as expressly modified herein, all of the terms and conditions
11 contained in Agreement No. 34668 are ratified and confirmed and shall remain in full force
12 and effect.
