SECOND AMENDMENT TO AGREEMENT NO. 34277

THIS SECOND AMENDMENT TO AGREEMENT NO. 34277 is made and entered, in duplicate, as of March 27, 2017, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 19, 2016, by and between LISA WISE CONSULTING, INC., a California corporation ("Consultant"), with a place of business at 983 Osos Street, San Luis Obispo, California 93401, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with coastal zone consulting services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34277 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to correct the term; and

WHEREAS, the Parties desire to add \$40,000 for a total not to exceed amount of \$160,000 and extend the term an additional one (1) year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

- 1. Section 1.A of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Hundred Sixty Thousand Dollars (\$160,000), at the rates or charges shown in Exhibit "B"."
 - 2. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on January 1, 2016, and shall terminate at 11:59 p.m. on April 1, 2018, unless sooner terminated as provided in this Agreement, or unless the services or the Project is

completed sooner. The term may be extended for one (1) additional one-year period, at 2 the discretion of the City Manager." 3 3.
