

1 FIRST AMENDMENT TO AGREEMENT NO. 30750

2 **30750**

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 30750 is made and
4 entered, in duplicate, as of December 9, 2008 for reference purposes only, pursuant to a
5 minute order of the City Council of the City of Long Beach at its meeting held September
6 4, 2007, and a minute order of the City Council of the City of Cerritos at its meeting held
7 on December 13, 2007, by and between the CITY OF LONG BEACH (hereinafter "Long
8 Beach"), and the CITY OF CERRITOS (hereinafter "Cerritos").

9 WHEREAS, the parties entered Agreement No. 30750 whereby Long
10 Beach agreed to provide animal control services to Cerritos; and

11 WHEREAS, the Agreement contains a provision allowing the parties, by
12 mutual agreement, to extend the term of the Agreement and the parties desire to do so;

13 NOW, THEREFORE, in consideration of the mutual terms and conditions in
14 the Agreement and in this First Amendment, the parties agree as follows:

15 1. Section 1 of the Agreement is hereby amended in its entirety to read
16 as follows:

17 "SECTION 1. TERM. The original term of this Agreement shall commence
18 at 12:01 a.m. on July 1, 2007, and shall terminate at midnight on June 30, 2008, and the
19 first extended term shall commence at 12:01 a.m. on July 1, 2008, and shall terminate at
20 midnight on June 30, 2010, unless sooner terminated as provided below."

21 2. Section 4.A. is hereby amended in its entirety to read as follows:

22 "A. For and in consideration of the rendition of services pursuant to this
23 Agreement, Long Beach shall be entitled to and shall retain any and all license fees and
24 other fees relating to animal control, which license fees and other fees shall be set forth
25 in Long Beach's Schedule of Fees and Charges, as periodically established and
26 amended by resolution and as approved by the City Council of Long Beach. In addition,
27 Long Beach shall be entitled to and shall retain all monies that it collects for the
28 impounding, boarding and placement of animals. The license and other fees shall be

1 those set forth in Long Beach's fee resolution, as periodically amended, and as adopted
2 by the Long Beach City Council. A schedule of license and other fees is attached as
3 Exhibit "A" and incorporated by this reference."

4 3. Section 4.C. is hereby amended in its entirety to read as follows:

5 "C. In the event and to the extent that the total amount of any and all fees
6 retained by Long Beach does not equal or exceed One Hundred Ninety-Six Thousand
7 Three Hundred Ninety-Two Dollars (\$196,392.00) on June 30, 2008, then Cerritos shall
8 pay to Long Beach the difference between said total fees and \$196,392.00. Payment of
9 the difference shall be made on or before July 31, 2008. In the event and to the extent
10 that the total amount of all license fees retained by Long Beach exceeds \$196,392.00 on
11 June 30, 2008, then said excess shall be divided equally between Long Beach and
12 Cerritos.

13 In the event and to the extent that the total amount of any and all fees
14 retained by Long Beach does not equal or exceed Two Hundred Three Thousand
15 Seventy Dollars (\$203,070.00) on June 30, 2009 with respect to the first extended term,
16 then Cerritos shall pay Long Beach the difference between the total fees and
17 \$203,070.00. Payment of the difference shall be made on or before July 31, 2009. In the
18 event and to the extent that the total amount of all license fees retained by Long Beach
19 exceeds \$203,070.00 on June 30, 2009, then the excess shall be divided equally
20 between Long Beach and Cerritos.

21 In the event and to the extent that the total amount of any and all fees
22 retained by Long Beach does not equal or exceed Two Hundred Nine Thousand Nine
23 Hundred Seventy-Four Dollars (\$209,974.00) on June 30, 2010 with respect to the first
24 extended term, then Cerritos shall pay Long Beach the difference between the total fees
25 and \$209,974.00. Payment of the difference shall be made on or before July 31, 2010.
26 In the event and to the extent that the total amount of all license fees retained by Long
27 Beach exceeds \$209,974.00 on June 30, 2010, then the excess shall be divided equally
28 between Long Beach and Cerritos."

1 4. Section 4.D. is hereby amended in its entirety to read as follows:

2 "D. In the event of termination of this Agreement pursuant to Section 7 or
3 Section 9, Long Beach shall retain fees as compensation for services provided by Long
4 Beach through the effective date of the termination. In the event and to the extent that
5 the total amount of any and all fees retained by Long Beach to the effective date of
6 termination does not equal or exceed Sixteen Thousand Three Hundred Sixty-Six Dollars
7 (\$16,366.00) for each month that the Agreement has been in effect until June 30, 2008,
8 then Cerritos shall pay to Long Beach the difference between the total fees to the
9 effective date of termination and the dollar figure obtained by multiplying \$16,366.00
10 times the number of months the Agreement was in effect between July 1, 2007 and June
11 30, 2008. A partial month shall be deemed a full month. Payment of the difference shall
12 be made within thirty (30) days of the effective date of termination. Any excess fees shall
13 be paid to Cerritos.

14 In the event and to the extent that the total amount of any and all fees
15 retained by Long Beach to the effective date of termination but prior to June 30, 2009
16 does not equal or exceed Sixteen Thousand Nine Hundred Twenty-Three Dollars
17 (\$16,923.00) for each month that the Agreement has been in effect until June 30, 2009,
18 then Cerritos shall pay to Long Beach the difference between the total fees to the
19 effective date of termination and the dollar figure obtained by multiplying \$16,923.00
20 times the number of months the Agreement was in effect between July 1, 2008 and June
21 30, 2009. A partial month shall be deemed a full month. Payment of the difference shall
22 be made within thirty (30) days of the effective date of termination. Any excess fees shall
23 be paid to Cerritos.

24 In the event and to the extent that the total amount of any and all fees
25 retained by Long Beach to the effective date of termination does not equal or exceed
26 Seventeen Thousand Four Hundred Ninety-Eight Dollars (\$17,498.00) for each month
27 that the Agreement has been in effect until June 30, 2010, then Cerritos shall pay to Long
28 Beach the difference between the total fees to the effective date of termination and the

1 dollar figure obtained by multiplying \$17,498.00 times the number of months the
2 Agreement was in effect between July 1, 2009 and June 30, 2010. A partial month shall
3 be deemed a full month. Payment of the difference shall be made within thirty (30) days
4 of the effective date of termination. Any excess fees shall be paid to Cerritos."

- 5 5. Exhibit "A" is attached hereto and incorporated by this reference.
- 6 6. Except as expressly amended in this First Amendment, the terms
- 7 and conditions to Agreement No. 30750 are ratified and confirmed and shall remain in full
- 8 force and effect.
