3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH APPOINTING A MEMBER AND
5 ALTERNATE TO THE LOS ANGELES GATEWAY REGION
6 INTEGRATED REGIONAL WATER MANAGEMENT JOINT
7 POWERS AUTHORITY GOVERNING BOARD

9 WHEREAS, the Los Angeles Gateway Regional Integrated Regional Water
10 Management Joint Powers Authority (GWMA) was formed in 2007 in response to the
11 passage of two voter approved water bonds; Proposition 50, passed in 2002 and
12 Proposition 84, passed in 2006; and

13 WHEREAS, the City of Long Beach is a member of the GWMA; and

14 WHEREAS, under the GWMA Joint Powers Agreement, each member
15 agency shall appoint one member and up to three alternate members to the Governing
16 Board in accordance with the GWMA Bylaws; and

17 WHEREAS, pursuant to the GWMA Bylaws, the member and alternate
18 members appointed by this Resolution shall hold office until September 30, 2025;

19 NOW THEREFORE, the City Council of the City of Long Beach resolves as
20 follows:

21 Section 1. Effective October 1, 2021, Stormwater/Environmental
22 Compliance Officer, Melissa You, is appointed to serve as the GWMA Board Member
23 representing the City of Long Beach.

24 Section 2. Effective October 1, 2021, Civil Engineer, Colin Averill, is
25 appointed to serve as Alternate Board Member representing the City of Long Beach.

26 Section 3. If neither the Member nor the Alternate Member is available,
27 the City Manager shall designate in writing a representative of the City of Long Beach.

28 Section 4. This resolution shall take effect immediately upon its adoption
