

1 FOURTH AMENDMENT TO AGREEMENT NO. 34903

3 THIS FOURTH AMENDMENT TO AGREEMENT NO. 34903 is made and  
4 entered, in duplicate, as of February 1, 2023, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 January 17, 2023, by and between HOMEBOY RECYCLING, a California social purpose  
7 corporation dba Homeboy Electronics Recycling ("Contractor"), with a place of business at  
8 130 W. Bruno Street, Los Angeles, California 90012, and the CITY OF LONG BEACH, a  
9 municipal corporation ("City").

10 WHEREAS, City and Contractor (the "Parties") entered into Agreement No.  
11 34903 (the "Agreement") whereby Contractor agreed to provide transportation and  
12 disposal services of electronic waste; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to  
14 extend the term to February 28, 2021; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement  
16 to extend the term to February 28, 2022; and

17 WHEREAS, the Parties entered into a Third Amendment to the Agreement  
18 to extend the term to November 30, 2022; and

19 WHEREAS, the Parties desire to extend the term to March 31, 2023;

20 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
21 conditions herein contained, the Parties agree as follows:


22 1. Section 2 of the Agreement is hereby amended to read as follows:


23 "2. TERM. The term of this Agreement shall commence at midnight on  
24 March 1, 2018, and shall terminate at 11:59 p.m. on March 31, 2023, unless sooner  
25 terminated as provided in this Agreement, or unless the services or the Project is  
26 completed sooner."

27 2. Except as expressly amended herein, all terms and conditions in  
28 Agreement No. 34903 are ratified and confirmed and shall remain in full force and effect.
